Voluntary Liability Disclaimer and Assumption of Risk

In consideration of being allowed to participate in the Sporting Clays Program (“the Program”), use the facility, the equipment and the land, I represent, warrant and agree as follows:

1. I acknowledge and appreciate the inherent danger in practicing the sport of sporting clays, target shooting, skeet shooting and any sport involving firearms and I voluntarily expose myself to that danger and assume all risks of injury and damage. **I will wear required eye/ear protection at all times during the scheduled experience in the manner in which it was designed.**
2. I, for myself, my executors, administrators, heirs, successors or assigns, voluntarily and knowingly release the Biltmore Company, its affiliated companies, their owners, officers, directors, agents, servants, employees, instructors and operators from all claims and demands of whatever nature, actions and causes of action, damages, costs, loss of service, expenses and compensation on account of or in any way growing out of my participation in the Program and use of the facilities and/or equipment, whether or not contemplated at the present time and whether or not they arise following the execution of this release.
3. I hereby agree to indemnify and hold the Biltmore Company and all parties listed in section 2 harmless from any and all expenses, claims, suits, demands, loss of services, costs and fees by me, my executors, administrators, heirs, successors or assigns, relating to any act or omission of mine resulting in personal injury or property damage to me.
4. I acknowledge receipt of the equipment assigned to me and of the conditions described herein.
5. On the occurrence of any damage or loss of the equipment assigned to me, while in my possession, I will immediately pay the Biltmore Company all sums incurred in the repair or value of the replacement thereof.
6. I acknowledge that no warranties or representations have been made by or on behalf of the Biltmore Company and I hereby rely on none.
7. I am an adult, legally competent, have no conditions that would prevent me from participating in the activity, and have signed this document as my own free act. I acknowledge that I have read these conditions, in their entirety, that I am in agreement with the terms thereof and assumption of the risks outlined herein.
8. A parent or guardian must accompany anyone 17 years of age and younger for ALL Outdoor Activities.
